# **Connecting People to Improve Care**

During the COVID-19 outbreak it has never been more important for carers, social care professionals and clinicians to be able to communicate with each other and the people they care for as effectively and securely as possible.

This guide outlines some of the key ways you can access and use technology to improve communication between your residents and health and social care professionals.

We know that Care Homes will be at very different stages on their technology journey and some may need extra help implementing innovations. # **NHS Mail**

Secure communication between health and social care services is now more important than ever. To support this a fast track implementation of NHSmail to the care sector, without the need to complete the Data Security and Protection Toolkit, has been put in place.

This is available to all Care Homes - you do not have to hold a contract with the NHS or Social Care.

Using NHS mail provides evidence to support elements of the Safe, Effective & Well Led KLOE's (Key Lines of Enquiry).

# How to register:

1. Complete this form: Social Care Provider NHSmail Form.

- a. You must complete and send this back in Word it won't work if you print it out and fill in by hand.
- b. You should provide mobile phone numbers not landlines as you will get a text with your password.
- c. If you are a head office applying for multiple sites, complete the same form and provide the Organisation Data Service code of each site. If you do not know your ODS codes you can look them up at <a href="https://odsportal.hscic.gov.uk/Organisation/Search">https://odsportal.hscic.gov.uk/Organisation/Search</a> or contact the NHS Digital helpdesk at <a href="mailto:exeter.helpdesk@nhs.net">exeter.helpdesk@nhs.net</a> to request for them to be sent to you.
- 2. Send the form to care.registration@nhs.net
- 3. You will get an email back in a couple of minutes to say your application is being processed. If there is a problem with the form you will also get an email back.
- 4. Within 1-2 days, you will receive an email from NHSmail welcoming you to your new account, as well as a text message with your password. Each provider will have one shared mailbox and two user accounts.

## **Microsoft Teams**

Microsoft Teams allows you to conduct video and audio calls, as well as send instant messages and find and share documents with anyone else who has an nhs.net email account.

Once you have an NHSmail account you can sign in with that email address.

#### **How to access Teams**

- 1. In your internet browser, go to teams.microsoft.com
- 2. Log in using your new NHSmail email address and password

## Video consultations

GP surgeries are now starting to use video consultations. Holding a video consultation is like a face-to-face appointment but means the GP does not have to visit your care home to give advice or write a prescription.

Most GP surgeries in Kent are using AccuRx. If the GP is using AccuRx for a video consultation they will send a meeting link to a smart mobile phone. Therefore, for this to work you will need the following:

- A smartphone, either with working Wi-Fi/3G/4G connection
- Your Internet Browser needs to have your phone's microphone and camera enabled (you can see how to alter this in your phone settings <a href="here">here</a>). You might also need to make sure you are using a <a href="supported browser">supported browser</a>.

 iPhones running older software that has not been updated (iOS 12 and earlier) will need to download the Whereby app to join the consultation)

You may want to consider putting a named person, or team, in charge of video consultations. Choose someone who is comfortable with the tech, as this will help everyone involved get the most out of the sessions.

# Some key points to remember:

- Make sure that the device (smart phone or tablet when available) is kept free from infection risk as much as possible (please refer to your infection control guidance0.
- Make sure that the **resident consents** to the consultation if they have capacity and that they are happy for the care home worker to be present / facilitate the consultation.
- Make sure that the video takes place in an appropriate place with as much confidentiality as possible – also quiet, calm and without interruptions.
- The **care worker may act as the link**, especially if the resident is hard of hearing or has difficulty understanding.
- If the care home has the facilities, then basic monitoring such as blood pressure / pulse / pulse oximeter / temperature may make the clinical decisions more accurate.
